#### **Referees – you have professional indemnity insurance cover**

If (and ONLY if) your Boxing SA Inc membership is up-to-date (ie financial), referees are covered by a five million dollar Professional Indemnity insurance policy with SportsCover. The policy covers qualified officials whilst acting in their judge or referee capacity, against claims arising from negligent acts, errors or omissions whenever or wherever committed or alleged to have been committed in connection with the sport provided the incident and any claim occur during the insured period. If you renew your membership prior to 1<sup>st</sup> February each year your insurance cover will continue without interruption, otherwise you will have a gap in cover.

#### **Ringside officials – Hepatitis B vaccination strongly recommended**

Hepatitis B is one of several blood-borne diseases that can cause serious illness. A tiny drip of blood containing the Hepatitis B virus can transmit the virus to others via cuts, or via contact with membranes such as the eye. This disease can be prevented by vaccination. Everyone is encouraged to have a Hepatitis B vaccination, but ringside officials such as referees, judges, timekeepers and gloving stewards in particular are strongly advised to do so. Your doctor can advise you on the cost of the vaccine.

# MEMBER PROTECTION DECLARATION

***This document must be completed and returned with your Individual Membership Form***

Boxing SA has a duty of care to its members and to the general public who interact with its employees, volunteers, members and others involved with its activities.

As part of this duty of care and as a requirement of our Member Protection Policy, we must enquire into the background of those applying for, undertaking or remaining in any work (paid or voluntary) that involves working with persons under the age of 18 years ("minors"), and in particular where that work involves direct and unsupervised contact with minors.

Coaches, officials, and members of teams travelling with minors are required to complete this declaration. In addition, coaches and designated officials will subsequently be required to consent to a Police Criminal History Check by applying for a "National Police Certificate" for any history of pending charges or convictions for offences against children, acts of violence, or supply of illicit drugs.

As you occupy, or are seeking to occupy, a position(s) deemed to have contact with minors, we are obliged to have you fill in and return the declaration below, which will be kept securely and treated in confidence.

If you do not return the completed declaration within 14 days, you will receive a warning notice prior to action being taken to terminate any position you hold or are applying for with our association.

If any of the clauses numbered 1 to 5 below are not true for you, you should cross out the relevant clause(s) and return the form. You will then be asked to provide details, and in addition you will be asked to provide written consent to a police record check. Boxing SA will have an independent person assess your situation in confidence and Boxing SA will advise you of their decision in writing.

4. I have never participated in, facilitated or encouraged any practice prohibited by the World Anti-Doping Agency Code or any other anti-doping policy applicable to me.
5. To my knowledge there is no other matter that Boxing SA may consider to constitute a risk to its members, employees, volunteers, athletes or reputation by engaging me.
